#### 3. Update on Implementation Grant.

The implementation grant is effective March 18, 2021, and half of the \$1,064,522 have been received by Fiscal Agent Bois de Sioux Watershed District. # 4. Approval of the Policy and Steering Committee Operating Guidelines.

Staples called for nominations for Secretary. Upon nomination by Vavra, seconded by LaValley, Backer was appointed Secretary. Upon nomination by Staples, seconded by Walkup, Vavra was appointed Treasurer. Morrill motioned, seconded by Klindt and carried unanimously, to appoint the Bois de Sioux Watershed District Administrator to take Policy Committee minutes.

### 6. Presentation of Fiscal Agent Contract.

Beyer presented the draft contract, which formalizes the services provided by the grant Fiscal Agent. **This agreement must be approved by each LGU and the BdSWD.** The Bois de Sioux Watershed District will review the contract at their April 15, 2021. It will then be forwarded to LGU representatives for consideration for approval.
