Beyer reported that the Bois de Sioux Watershed District has submitted the signed grant agreement for the second round of watershed implementation funds, but BWSR has not responded with their signature and first grant disbursement yet. Staples reported that BWSR recently awarded a \$200,000+ competitive grant to Traverse SWCD.

Beyer asked when LGU's should evaluate their unused WBIG #1 grant funds, to consider returning allotments for other LGU's to utilize; the consensus was after the end of the calendar year.

House provided an in-depth presentation of projects that have been completed by Grant SWCD throughout Grant County, including streambank/shoreline stabilizations, sediment basins, systems to prevent gully's, an urban rain garden, etc. Typically, projects are offered for 75% cost share, and landowners to apply their own equipment and labor towards their 25% cost share. Wells are sealed at 50% cost share, up to \$400. House described recent staff changes within Grant SWCD, the County, and NRCS. He also stated that an engineer has been hired, shared by several SWCD's, with the goal to have projects shovel ready in advance of grant executions. Lillemon described changes proposed to the Grant County Shoreland Ordinance. House recommended that, upon the publishment of the Traverse County groundwater atlas, that USGS be invited to present to the BdS-M Joint Comprehensive Watershed Management committees.
