The following public hearing will be held on Monday, December 21, 2020, at 10:00 AM: The final hearing on the repair petition, the detailed survey report, and the viewers' report of the redetermination of benefits and damages for the repair of Judicial Ditch No. 6 (JD #6) in Wilkin County and Traverse County, Minnesota.

Pursuant to Minn. Stat. § 103E.325, the following actions have occurred: (1) The repair petition is pending. (2) The engineer's detailed survey report is filed. (3) The viewers' report is filed. (4) The time and place set for the final hearing is as described above. (5) The proposed drainage project will occur along the entire length of the JD #6's main channel and lateral 1. The repair will include excavating the channel bottom to the original legal ditch grade and resloping of the channel side slopes to create a more stable vegetated channel. Excavated material (spoil) will be used to construct a berm parallel along the ditch and side inlet culverts will be installed through the berm to provide drainage from the fields into the ditch. The top elevation of the berm will be built to specific elevations at each mile so that any flow greater than the 10 year event will exceed the channel capacity. The general description of JD #6 main commences at the southwest corner of Section 35, Township 130, Range 46, Campbell Township, Wilkin County; thence running easterly, along the south line of Section 35, to the southeast corner of Section 35; thence running northerly, along the east line of Section 35 and Section 26, to the northeast corner of Section 26; thence running easterly, along the north line of Section 25, to the northeast corner of Section 25; thence running northerly, along the west line of Section 24, to a tributary of the Rabbit River where the channel outlets. The general description of JD #6 Lateral 1 commences at the northwest corner of Section 27, Township 130, Range 46, Campbell Township, Wilkin County; thence running easterly along the north line of Section 27 and Section 26, to the northeast corner of Section 26 where it outlets into the JD #6 main channel.
