#### BOIS DE SIOUX WATERSHED DISTRICT BOARD MEETING MINUTES June 16, 2022

CALL TO ORDER The meeting was called to order by President Vavra at 8:08 a.m. Present in the District Office: Linda Vavra, Ben Brutlag, Jerome Deal, Steven Schmidt, Allen Wold. Absent: Jason Beyer, Doug Dahlen, Scott Gillespie, John Kapphahn. Also present in the District Office: District Engineer Chad Engels, Engineer Technician Troy Fridgen, and Administrator Jamie Beyer. Staff present online: Engineer James Guler and Attorney Lukas Croaker. AGENDA Upon motion by Wold, seconded by Schmidt and carried unanimously, the agenda was approved with the following addition: Permit Application #22-066, Richard Sanasack, Overflow Pipe, Tara Township, Traverse County. CONSENT AGENDA Upon motion by Deal, seconded by Wold and carried unanimously, the Consent Agenda was approved. PUBLIC COMMENT Joe Caruso and James Hanson presented information on Summit's installation of a CO2 pipeline CO2 SUMMIT through the northern part of Wilkin County and southwestern corner of Otter Tail County. The 4" -PIPELINE 8" line will be installed under a minimum 54" of cover. Summit is obligated to restore disturbances to surface and subsurface sites. Summit is pursuing voluntary easement, utilizing a three-part survey to identify buildable sites (physical survey, cultural survey, environmental survey). Ellingson will be the subcontractor tasked with restoring affected tile lines (landowners may also select their own contractor). District Engineer Chad Engels relayed that severing and replacing/repairing tile lines are not a permittable event for the District, but that crossing a legal 103E ditch would require a District permit. #21-050 The permit application meets District standards, but was included on the agenda to provide a forum FINDLAY & ZYCH for public comment from neighboring landowners. Mr. Tom Kruger and his mother provided concerns that downstream public water could not hold additional flow and don't want to receive water at a faster rate than the waterway can handle. Engineer Technician Troy Fridgen relayed willingness on Dale Zych's behalf to clean downstream public waters. President Vavra encouraged landowners to work together. Landowner Mary Jo Stueve asked questions about map legends and symbols. #22-067 Applicant for permit application #21-067 is busy in the field, but has proposed to bore under the S. MILLER road and connect subsurface drainage to a permitted drainage ditch. Surface water will continue to flow to WCD-1. Upon motion by Deal, seconded by Schmidt and carried unanimously, a variance for crossing the subwatershed boundary to the Rabbit River was approved. #22-066 Mr. Richard Sanasack spoke to the need for an overflow culvert adjacent to his property in order to **D. SANASACK** alleviate road overtopping. Tara Township Official Scott Gilsdorf stated that the township signed the permit application, and as the road authority, supports the project. Mr. Sanasack seeks on-site construction management for installation of the culvert, and is seeking cost-share. The project cost estimate is \$21,000 - \$25,500. District Engineer Chad Engels stated that townships typically install and fund these types of projects. Mr. Sanasack stated that he has been stranded at his property for up to 12 days due to flooding. Discussion was held as to the apparent inadequacy of the size of the current culvert/bridge. Upon motion by Wold, seconded by Deal and carried unanimously, the request was tabled to the July meeting. **GCD #8** A June 23 meeting has been set between Grant County officials, BdSWD staff, and landowners Mr. Tim Backman, Mr. Kevin Deal, and Mr. Pat Haney. GCD #21 An improvement/repair petition has not been received. The contractor has begun removing topsoil. A landowner has asked for additional compensation for TCD #35/ Redpath land acquired by the District outside of the drainage proceedings, and has stated that he will **REDPATH PHASE** prevent access to his parcel. Upon motion by Wold, seconded by Deal and carried unanimously, #1 Attorney Lukas Croaker is authorized to send a letter detailing property owner rights following redetermination and repair proceedings.

WCD #SUB-1	The District is waiting for \$5,000 in order to fulfill bond requirements.
JD#6 UPDATE & BOND	A portion of the project was reseeded in May; the District is monitoring establishment of cover. Upon motion by Wold, seconded by Brutlag and carried unanimously, the board approved the application of \$8,918.07 in project expenses
DISTRICT WORKSHOPS	Board managers discussed topics to be included in upcoming district landowner workshops.
REDPATH PHASE 2 FUNDING STRATEGY	Engineering staff presented three options for Phase 2 of the Redpath Project (comprised of a \$7 Gmillion Mustinka River Rehabilitation and \$10 million impoundment construction), now that the legislative session has ended without bonding for the Flood Hazard Mitigation Program. 1) The District could put Phase 2 on hold, but would likely forfeit a \$2.4 million grant from the Lessard Sams Outdoor Heritage Grant and possibly forfeit \$4.4 million in additional Mustinka River Rehabilitation grants. 2) The District could request that the Red River Watershed Management Board and the District split the \$10 million obligation. 3) Phase 2 could be broken into two sub-phases (A & B), in order to provide a bid package and start construction of Phase 2A next summer.
REDPATH PHASE 2 DECLARATION	Engineer James Guler presented a Minnesota Wetland Conservation Act Declaration of Restrictive Covenants for Project-Specific Wetland Replacement, used to fulfill permit requirements to designate Redpath project wetlands. District Attorney Lukas Croaker included language to specify that
OF RESTRICT CONVENANTS	maintenance and restoration will occur, in accordance with the District's wetland plan approved specifically for the project. Upon motion by Deal, seconded by Brutlag and carried unanimously, President Vavra is authorized to sign the declaration and staff are authorized to record the declaration contingent upon approval from Traverse SWCD/BWSR.
LTWQIP NO. 1 PHASE #2	Board managers reviewed a Lake Traverse Water Quality Improvement Project No. 1 Phase #2 final balancing order for materials installed above the contract price of \$435,279.50 and Pay Application #2. Wold motioned, seconded by Deal and carried unanimously, the Final Balancing Change Order in the amount of \$35,879.50 and Pay Application No. 2 in the amount of \$39,298.65 (includes the Final Balancing Change Order) were approved.
LTWQIP NO. 2 PHASE #3	A cost estimate for Lake Traverse Water Quality Improvement Project No. 1 Phase #3 was presented. A meeting will be held with landowners in July.
640 <sup>TH</sup> ROAD RAISE	No contact has been received from Dollymount engineering staff.
SPRING FLOODS	Engineering staff toured District flooding hotspots this spring.
WESTERN 32 TREE REMOVAL	Engineer Technician Troy Fridgen received a request from an individual to remove dead ash trees on the District's property in Otter Tail County, Western Township, Section 32. Upon motion by Schmidt, seconded by Wold, legal staff are authorized to create a liability waiver to be used for the individual, upon consent by the lessee.
DISTRICT VEHICLE	The District's 2001 Chevrolet Suburban is requiring more frequent repairs. Upon motion by Deal, seconded by Schmidt and carried unanimously, staff are authorized to purchase a new vehicle with riparian funds, and trade-in/sell the 2001 Chevrolet Suburban.
JCWMP REIMBURSEMENT	Board managers reviewed reports for the Joint Watershed Based Implementation Fund Grant C21- 9685. Upon motion by Kapphahn, seconded by Dahlen and carried unanimously, a disbursement of \$4,043.02 was approved for costs incurred by the District.
WBIF GRANT #2	Board managers reviewed the budget proposed for the second Watershed Based Implementation Fund grant, expected in the amount of \$1,064,522. Upon motion by Wold, seconded by Deal and carried unanimously, staff are authorized to submit a grant application and workplan.
RECORDS RETENTION SCHEDULE	Administrator Beyer stated that she could not find that the District had previously approved a records retention schedule, which describes the conditions under which records can be destroyed. Upon motion by Wold, seconded by Deal and carried unanimously, legal staff are authorized to draft a record retention schedule for subsequent consideration by the board.


PAY EQUITY	Administrator Beyer stated that for compliance with DNR Lessard Sams Grant eligibility, the District must be up-to-date on its Pay Equity Compliance. Employees identified applicable job descriptions from the Minnesota State Job Match System. Points were then assigned and averaged. Upon motion by Deal, seconded by Schmidt and carried unanimously, the Pay Equity Implementation Report was approved for submission and posting.
TORT WAIVER	Upon motion by Brutlag, seconded by Deal and carried unanimously, to not waive the monetary limits on tort liability established by Minn. Stat. § 466.04.
ANNUAL ORGANIZATION RESOLUTION	Upon motion by Deal, seconded by Schmidt and carried unanimously, the 2021 – 2022 Annual Organization Resolution will be maintained and continued through the July meeting, so that elections can be held with greater board manager participation.
CONFLICT OF INTEREST POLICIES REVIEW	Administrator Beyer relayed that DNR grant administrators have requested that the District annually review applicable Conflict of Interest policies. Upon motion by Deal, seconded by Schmidt and carried unanimously, the District's Conflict of Interest Policy, and 05/19/22 and 09/16/21 DNR Conflict of Interest Disclosure Policies were reviewed and approved without change.

























Good afternoon,

Considering we have not dealt with many legal ditch system transfers via an improvement procedure, Chad requested that I send an email detailing the process for the transfer and improvement of Grant County Ditch No. 21 ("GCD #21"). To start, it is important to note that there are several ways in which a legal ditch system can be transferred from a county to a watershed district. The following procedures may be used for such transfer:

- 1. If directed by a county board (initiated by: (a) the county board, (b) a petition from an interested landowner, or (c) the watershed managers) Minn. Stat. § 103D.625, subd. 1;
- 2. Construction of a new drainage system or improvement to a drainage system is automatically filed with the watershed managers Minn. Stat. § 103D.625, subd. 4; or
- 3. A complex process outlined under Minn. Stat. § 103E.812 (not applicable).

Here, Grant County (the "County") and the Bois de Sioux ("BdS") desire to utilize the simplest process to transfer GCD #21 from the County to the BdS, a petition for improvement. Minn. Stat. § 103D.625, subd. 4 provides, "**Construction of** new drainage systems or **improvements of existing drainage systems in the watershed district must be initiated by filing a petition with the managers**. **The proceedings** for the construction or improvement of drainage systems in the watershed district **103E**..." (Emphasis added).

The petition referenced in the previous statute is a petition for improvement. Requirements for the petition can be found under Minn. Stat. §§ 103E.202 (Petitions) and 103E.215 (Improving Drainage Systems). As stated under Minn. Stat. § 103D.625, subd. 4, the petition must be filed with the managers (BdS) who then follow the standard improvement procedures under Minn. Stat. Chapter 103E. The transfer of the ditch system occurs through the improvement proceedings. According to the MN Attorney General, "[t]he legislature intended to statutorily transfer jurisdiction over new and improved county ditches to the watershed district permanently without requiring the watershed district to follow the takeover procedures of Minn. Stat. § 112.65, subd. 1 [now Minn. Stat. § 103D.625, subd. 1]" Minn. Op. Att'y Gen. 206A (1988). The BdS will obtain jurisdiction of GCD #21 upon filing of the petition and will take over GCD #21 without having to go through Minn. Stat. § 103D.625, subd. 1 proceedings. Because this improvement likely consists of the entire extent of the ditch system, the entire system will transfer from the County to the BdS. The petition for improvement should reference this transfer (John Kolb and I previously discussed incorporating that language into the petition).

"When a petition and the bond required by section 103E.202 are filed, the auditor [BdS Administrator] shall present the petition to the board at its next meeting . . ." Minn. Stat. § 103E.215, subd. 5. After the petition and bond are filed in conformance with Minn. Stat. §§ 103E.202 & 103E.215, the BdS attorney has 30 days to review the petition and bond. The attorney must: (1) refer the petition and bond back to the petitioners if it does not meet the requirements, with the . . . attorney's opinion describing the deficiencies of the petition; or (2) refer the petition to the drainage authority. Minn. Stat. § 103E.238. "Within 30 days after receiving a petition and bond from the . . . attorney, the drainage authority shall, by order, appoint an engineer to make a preliminary survey within a prescribed time." Minn. Stat. § 103E.241, subd. 1. Having the attorney review the petition and bond before the meeting may be best practice to ensure the petition is not deficient and the managers can appoint an engineer to prepare the preliminary survey at its meeting. Upon appointing the engineer, the BdS will continue through the Minn. Stat. Chapter 103E proceedings.

That was obviously a lot to take in, if anyone has any questions or comments on the transfer or improvement, please let me know.

# STATE OF MINNESOTA GRANT COUNTY BOARD OF COMMISSIONERS DRAINAGE AUTHORITY FOR GRANT COUNTY DITCH 21

In the matter of the Improvement of							
Grant County Ditch 21							

Petition for Improvement and Separable Maintenance Request

For their petition for the improvement of Grant County Ditch 21 (hereinafter "CD 21"), the undersigned Petitioners state and allege the following:

- Petitioners file this petition for improvement of CD 21 pursuant to statutes section 103E.215.
- CD 21 provides beneficial drainage to agricultural properties and Township and County roads in Sections 4, 5, 7, 8, 9, 10, 15, 16, 17, 18, 19, 20, and 21 of Delaware Township (Township 128 N, Range 43 W), Grant County, Minnesota.
- 3. CD 21 is in need of repair. CD 21 has remained in service since its original establishment in 1914. The original ditch consisted of the Main and four branches. There's a 5<sup>th</sup> branch that is known as "Original Tile Main" which is mostly part of Branch 1.
- 4. Being over 100 years old, the tile is experiencing more frequent failure and is at the end of its useful life.
- 5. Even in a repaired state, CD 21 is inadequate to support beneficial drainage for current farming and drainage practices. CD 21 has insufficient capacity and needs enlarging to furnish sufficient capacity. CD 21 does not meet current design criteria: the original construction of CD 21 was not deep enough to accommodate adequate drainage to much of the watershed it was intended to serve; new drainage and farming practices in

the watershed of the ditch create further need for increased tile capacity; and shallow installation depth must be corrected to reduce frequency of repair to accommodate current farming implements.

- 6. The proposed improvements include: lowering the depth of the improved portions of the drainage system to accommodate current farming practices, tile outlets and improve drainage efficiency; increasing the size of existing tile segments to accommodate improved flow; construction of new surface intakes where necessary to provide improved, buffered and stabilized inlets and to prevent erosion of soil into the system; and improve crossings.
- 7. The course of the proposed improvement is described as follows:
  - Branch 1: from its junction with the Main on the east line of SW ¼ of §18, T128N,
     R43W to its terminus along the east line of the SE ¼ of the NW ¼ and the west line of the SW ¼ of the NE ¼ of §7, T128N, R43W.
  - b. Branch 1 Fork: from its junction with Branch 1 along the north line of the SW ¼ of the SE ¼ and the south line of the NW ¼ of the SE ¼ of §7, T128N, R43W to its terminus on the east line of the SW ¼ of the SW ¼ and the west line of the SE ¼ of the SW ¼ of §7, T128N, R43W.
  - c. Branch 2: from its junction with the Main on the north line the NW ¼ of the SW ¼ of §17, T128N, R43W through portions of the NW ¼ and NE ¼ of §20 to its terminus in the SE ¼ of the SE ¼ of §17, T128N, R43W.

- d. Branch 2 Fork: from its junction with Branch 2 in the NE ¼ of §20, T128N, R43W south through the NE ¼ of the SE ¼ of §20 to its terminus in the NW ¼ of §21, T128N, R43W.
- e. Branch 3: from its junction with Branch 4 in the SE ¼ of the NW ¼ of §17, T128N,
  R43W to its terminus in the south half of the NW ¼ of §16, T128N, R43W.
- f. Branch 4: from its junction with the main line in the SE ¼ of the NW ¼ of §17,
   T128N, R43W to its terminus in the SE ¼ of the NE ¼ of §8, T128N, R43W.
- g. Main: from the outlet in the SW ¼ of §19, T128N, R43W to its terminus in the middle of section §17, T109N, R41W.
- 8. The improvement passes over 54 40-acre or smaller parcels under the following ownership:





This letter concerns your request for Department of the Army authorization to place fill material into approximately 39.44 acres of waters of the United States, including approximately 0.85 acres of the Mustinka River (Judicial Ditch 14), 27.2 acres of wetlands associated with the construction of berms and placement of control structures, 0.67 acres associated with Ditch 35 relocation, 3.74 acres associate with the mitigation site and 6.98 acres of ditch bottom. The project is depicted on the enclosed drawings labeled 2010-04199-EJI Page 1 of 4 to 4 of 4. The project site is in Sections 15, 16, 21, 22, 23, 24, 25, 26, 27, 28 Township 128 North Range 45 West, Traverse County & Sections 19, 20, 30, Township 128 North Range 44 West, Grant County Minnesota.

This letter contains an initial proffered permit. Also enclosed is a Notification of Administrative Appeal Options and Process (NAP) fact sheet and Request for Appeal (RFA) form for information regarding your right to object to these determinations.

If you object to the terms and/or conditions of this initial proffered permit, please see Section I-A. You must complete Section II of the RFA and submit it to the **District Engineer** in accordance with 33 C.F.R. Part 331. Your objections to the initial proffered permit must be received by the **St. Paul District Office** within 60 days of the date of the NAP or you will forfeit your right to appeal the permit.

Before accepting the RFA, the Corps must determine that it is complete, that it meets the criteria for appeal under 33 C.F.R. § 331.5, and that it has been received by the District or Division Office within 60 days of the date of the NAP.

It is not necessary to submit an RFA form to the Corps District or Division Office if you do not object to the initial proffered permit or the approved jurisdictional determination enclosed with this letter.

The preliminary JD prepared for the site described above is not appealable. The preliminary JD is a written indication that there may be waters or wetlands subject to federal jurisdiction on the site or an indication of the approximate location(s) of waters or wetlands on a parcel. If you wish to receive an approved jurisdictional determination, please see Section I-E. If this preliminary JD is acceptable, please sign and date both copies of the preliminary JD form and return one copy to the address below within 30 days from the date of this letter.

If the permit, with all conditions, is acceptable, the permittee or authorized representative should sign on the line above the words "PERMITTEE SIGNATURE," add the date, print or type the signatory's name clearly underneath the signature, and return to this office, **Attention: Regulatory Division**. The District Engineer, or his designated representative, will then sign return to you for your records. The permit is not valid without that signature.

Your DA permit will not be valid until we have returned a copy to you bearing both your signature and the signature of the appropriate Corps official.

You are authorized to discharge fill material into approximately 39.44 acres of waters of the United States, including approximately 0.85 acres of the Mustinka River (Judicial Ditch 14), 27.2 acres of wetlands associated with the construction of berms and placement of control structures, 0.67 acres associated with Ditch 35 relocation, 3.74 acres associate with the mitigation site and 6.98 acres of ditch bottom. The authorized work area is shown on the enclosed drawings labeled 2010-04199-EJI page 1 of 4 to page 4 of 4.

### **Project Location:**

The project site is located in: Sections 15, 16, 21, 22, 23, 24, 25, 26, 27, 28 Township 128 North Range 45 West, Traverse County & Sections 19, 20, 30, Township 128 North Range 44 West, Grant County Minnesota.

### **Permit Conditions:**

### **General Conditions:**

- 1. The time limit for completing the work authorized ends on December 31, 2027. If you find that you need more time to complete the authorized activity, submit your request for a time extension to this office for consideration at least one month before the date is reached.
- 2. You must maintain the activity authorized by this permit in good condition and in conformance with the terms and conditions of this permit. You are not relieved of this requirement if you abandon the permitted activity, although you may make a good faith transfer to a third party in compliance with General Condition 4 below. Should you wish to cease to maintain the authorized activity or should you desire to abandon it without a good faith transfer, you must obtain a modification of this permit from this office, which may require restoration of the area.
- 3. If you discover any previously unknown historic or archaeological remains while accomplishing the activity authorized by this permit, you must immediately notify this office of what you have found. We will initiate the Federal and state coordination required to

determine if the remains warrant a recovery effort or if the site is eligible for listing in the National Register of Historic Places.

- 4. If you sell the property associated with this permit, you must obtain the signature of the new owner in the space provided and forward a copy of the permit to this office to validate the transfer of this authorization.
- 5. If a conditioned water quality certification has been issued for your project, you must comply with the conditions specified in the certification as special conditions to this permit. For your convenience, a copy of the certification is attached if it contains such conditions.
- 6. You must allow representatives from this office to inspect the authorized activity at any time deemed necessary to ensure that it is being or has been accomplished in accordance with the terms and conditions of your permit.

As compensatory mitigation for unavoidable impacts to 27.2 acres of wetlands and 0.85 acres of the Mustinka River (JD 14) the applicant shall perform permittee responsible compensatory mitigation as outlined in the document "Redpath Wetland Mitigation Plan, Traverse County, Minnesota" dated January 2021, including the relocation of approximately 6.98 acres of JD 35.
- 2. The work required for the permittee responsible mitigation must be completed prior to beginning phase 2 construction for the overall flood damage reduction project.
- 3. The permittee responsible mitigation site developed in accordance with the "Redpath Wetland Mitigation Plan, Traverse County, Minnesota" dated January 2021, shall be protected in perpetuity by covenants or conservation easement or other land use restrictions acceptable to the District Engineer that prohibit incompatible uses. A certified copy of the conservation easement shall be provided to this office within 90 days of completion of the permittee responsible mitigation site and prior to the expiration of this permit.




Figure 1.1 - Redpath Impoundment and Watershed





Figure 1.2 - Redpath Impoundment Project Layout

This letter is submitted by the Minnesota Pollution Control Agency (MPCA) under authority of Section 401 of the Clean Water Act (33 USC 1251 et seq.), Minn. Stat. chs. 115 and 116 and Minn. R. 7001.1400-1470, R. 7050, R. 7052, and R. 7053.

The applicant, Bois de Sioux Watershed District (BDSWD), is proposing the construction of the Redpath Flood Damage Reduction Project. The project location is: Sections 15, 16, 21, 22, 23, 24, 25, 26, 27, 28 Township 128 North, Range 45 West, Grant County and Sections 19, 20, 30 Township 128 North, Range 44 West, Traverse County, Minnesota.

The construction of the Redpath Flood Damage Reduction project would discharge dredged or fill material into the Mustinka River, also known as Judicial Ditch (JD) 14, Traverse County Ditch 35 and Traverse County Ditch 24 and adjacent wetlands. The project would place fill in approximately 0.85 acres of the Mustinka River and 29.62 acres of wetlands.

The applicant will mitigate the adverse impacts to wetlands by creation of an onsite mitigation area under perpetual conservation easement. BDSWD will establish a real estate instrument to protect the mitigation site and ensure the wetlands will exist in perpetuity. The mitigation would restore approximately 32.2 acres of wetlands and 12,591 linear feet of re-meandered Mustinka River.

The MPCA certifies the referenced project because there is reasonable assurance that the activity will be conducted in a manner that will not violate applicable water quality standards, provided the following conditions are complied with. These Conditions include:

- Within 14 days of the completion of the conservation easement to protect the mitigation, the BDSWD shall provide the MPCA with a letter confirming the establishing of the easement and describing the real estate instrument that ensures the mitigation will be protected. If onsite mitigation and a conservation easement are not determined to be the appropriate mitigation for the project, the proposer shall provide the MPCA with written notification about the mitigation.
- 2) The applicant will develop a plan for the use of in-water Best Management Practices (BMPs) to minimize turbidity and sedimentation during construction. The in-water BMPs must be used during all in-water work, including culvert installation associated with the bypass corridor and road crossing of the wetland. The plan must be submitted to the MPCA for approval before any in-water construction activities commence. A copy of the plan must also be available on the project site.
- 3) Construction of the by-pass channel must occur in the absence of water flow to minimize downstream sedimentation.
- 4) The project must be constructed in phases over a four year period, with phased restoration and vegetation establishment, as described in on pages 8 and 9 of the Environmental Assessment Worksheet. Each phase is considered complete when vegetation is successfully established. Except where parts of future phases are begun to efficiently use construction materials, the following phase shall not begin until vegetation is established from the previous phase.

The Mustinka River is Impaired for Aquatic Life due to high turbidity and low dissolved oxygen (DO). In the process of constructing this project, the applicant and their designated contractors are not authorized to exacerbate the above mentioned impairments. In addition, the applicant and their contractors are required to comply with all conditions of this MPCA 401 Water Quality Certification.

The Bois de Sioux Watershed District shall inform the MPCA of any additional water quality impacts this project may have, before they occur, to determine if further review or authorization is required. This includes any additional fill, excavation, dredging, additional structures, and temporary impacts not shown in the final plans.

This MPCA decision is made, in part, on the applicant's representations that environmental review under the Minnesota Environmental Quality Board's Rules, Minn. R. ch. 4410, is not needed for the project or, alternatively, that all necessary environmental reviews and related decisions have been completed. If environmental review for this project is needed and has not been completed, this MPCA Certification decision is null and void and of no legal effect. In that situation, MPCA reserves the right to make a Section 401 decision when the environmental review process is completed.



#### Introductions

Introductions were made.

#### **Brief History of North Ottawa**

Ebbenga and Vavra provided a brief history of the project, with contributions from other Project Team members, describing the primary function of the facility for flood damage reduction (FDR), secondary function to provide natural resource enhancements (NRE's), and the utilization and funding derived from agricultural leases.

#### Policies: 10-Year Operations and Maintenance Agreement

The current O & M Agreement was mailed/emailed to all Project Team participants. The facility's agricultural leases expire in 2022, so new leases will need to be enacted for crop year 2023. Because construction of the facility was paid for by state bond funds, the Minnesota Management and Budget (MMB) office requires that we use their lease form, and their approval is required. Beyer reported that it can take 6 - 9+ months to get MMB's approval, so she has already had MMB approve the lease form for 2023.

The BdSWD will approve the lease format in December and begin advertisement; rental bids are reviewed and approved in January, and rent is due March 1<sup>st</sup>.

In 2021, the District offered 2- and 3-year lease contracts, and saw a noteable increase in bid rental offers. Because the District anticipated the formation and enactment of the North Ottawa Project Team, a 2-year lease was utilized for crop years 2021 and 2022.

Project Team members requested a copy of the lease for their consideration.

#### **Policies: Project Team Duties**

Project Team duties are included in the O & M Agreement, see Section III and Exhibit B. Beyer will mail and collect signed Project Team Statements of Commitment. Ebbenga added that cost-share for meeting facilitators are available through the Flood Damage Reduction Workgroup.

#### **Policies: Budget**

Currently, there is approximately \$71,000 in the North Ottawa fund. Engineer Technician Troy Fridgen had provided the following repairs in progress:

- 1. Gravel will be applied to the center North-South road (\$11 \$12,000)
- 2. Three gates to keep vehicles off roads/dikes are being made, because signs aren't working by themselves (\$10,000 installed?)
- 3. One aluminum gate will replace wooden stop logs on A4 (this is the most used gate within the impoundment to manipulate water levels for NRE's, used to flood the other cells after harvest)
- 4. Some side inlet culverts are being fixed along the collection channel

These repairs may be \$25,000 - \$30,000 total.

Fridgen requested that the Project Team consider what to do with A3. This cell was not farmed – he recommends that a cover crop be planted to prevent/slow weed growth. Project Team members discussed different cover crop options, including rye, Japanese millet, oats, etc and the NRE benefits associated with those crops. Kapphahn can provide prices and coordinate seed purchase, delivery, and planting. Beyer offered that a cell could be subdivided to grow more than one type of cover crop.

Project Team members discussed the need for facility road signage – Pine to Prairie, MNDOT, and Wendell/Herman gas stations were identified as potential avenues.

#### Spring/Summer/Fall Operations

Brutlag relayed how the Impoundment was utilized Spring 2022, which had a late spring flood and several subsequent storm events, requiring gate manipulations to ease possible flood impacts and/or flooding perceptions downstream. Despite these flooding challenges, the agricultural cells were able to be planted.

Project Team members discussed interest in monitoring equipment. The system originally installed with the facility has been defunct for several years – the technology was not initially installed correctly and relies on an extensive system of batteries. The equipment manufacturer has visited the site and was unable to repair the system.

Herwig described DNR research noting one species that uses the Impoundment for nesting. Brown commended the District on its cattail control in A4/B4, which were found by District staff to be too shallow to drown the cattails.

#### **Next Meeting**

Project Team members requested a meeting prior to harvest, early September?, and a second meeting in November. Beyer will coordinate the logistics of setting and preparing meetings for the Project Team.

District staff have tabled requests/proposals from outside entities for a variety of new activities, and will begin the process of bringing interested parties to future Project Team meetings – enhancement proposals have included bathrooms, camping spots, bird watching blinds, wild rice production, paved walking paths, etc.

- September 1Administrators submit resolutions and background information documents to the<br/>MAWD office at emily@mnwatershed.org by September 1. If more time is needed,<br/>please contact the MAWD office so the MAWD Resolutions Committee is aware that<br/>another resolution may be submitted. The latest possible date to submit a resolution is<br/>60 days before the annual meeting (October 4). We ask that resolutions be submitted<br/>according to the described timeframe to ensure distribution to members for discussion<br/>by your boards in November.

NOTE: If all the requested information is not included, the Resolution will NOT be accepted.

- September / October The MAWD Resolutions Committee will review the resolutions, gather more information or ask for further clarification when deemed necessary, work with the submitting watersheds to combine similar resolutions, reject resolutions already active, discuss and make recommendations on their passage to the membership.
- October 31 Resolutions (with committee feedback) will be emailed to each organization by Oct 31.

NOTE: If at all possible, please hold a regional meeting to discuss the Resolutions BEFORE the annual conference.

- November Members should discuss the resolutions at their November meetings and decide who will be voting on their behalf at the annual meeting (2 voting members and 1 alternate are to be designated per watershed organization)
- **December 3** Delegates discuss and vote on resolutions at the annual resolutions hearing. Please be prepared to present and defend your resolution.
- DecemberLegislative Committee will review existing and new resolutions and make a<br/>recommendation to the MAWD Board of Directors for the 2023 legislative platform.
- **December 2022** MAWD Board of Directors will finalize the 2023 legislative platform.

January 2023 Legislature returns for the 93<sup>rd</sup> Legislature, 2023-2024.

NOTE: Resolutions passed by the membership will remain MAWD policy for five years after which they will sunset. If a member wishes to keep the resolution active, it must be resubmitted and passed again by the membership. # FINANCE ISSUES

#### 2021-01A: Support SWCD Capacity Fund Sources

MAWD supports SWCD capacity funds to come from county and state general funds.

#### 2021-01B: Support Clean Water Funds for Implementation, Not Capacity

MAWD Supports Clean Water Funds being used for implementation and not for capacity.

#### 2021-02: Support Capacity Funding for Watershed Districts

MAWD supports capacity base funding resources directed to non-metro watershed district who request this assistance, to implement the activities as outlined in approved watershed district watershed management plans or comprehensive watershed management plans.

#### 2021-05: Support Crop Insurance to Include Crop Losses Within Impoundment Areas

MAWD supports expansion of Federal Multi-Peril Crop Insurance to include crop losses within impoundment areas.

#### 2019-06: Oppose Legislation that Forces Spending on Political Boundaries

MAWD opposes legislation that establishes spending requirements or restricts watershed district spending by political regions or boundaries.

#### 2018-02 Increase the \$250k General Fund Tax Levy Limit

MAWD supports legislation to increase or remove the \$250,000 general fund ad valorem tax levy limit set in MN statute 103D.905 Subd. 3. If the limit is raised to a new dollar amount, MAWD supports an inflationary adjustment be added to statute.

#### 2019-08: Heron Lake Watershed District General Operating Levy Adjustment

MAWD supports an increase in Heron Lake Watershed District's general operating levy cap from \$250,000 to an amount not to exceed \$500,000.

#### 2019-09: Shell Rock River Watershed District General Operating Levy Adjustment

MAWD supports an increase in Shell Rock River Watershed District's general operating levy cap from \$250,000 to an amount not to exceed \$500,000.

#### 2019-10: Pelican River Watershed District General Operating Levy Adjustment

MAWD supports an increase in Pelican River Watershed District's general operating levy cap from \$250,000 to an amount not to exceed \$500,000.

#### 2019-11: Buffalo Red River Watershed District General Operating Levy Adjustment

MAWD supports an increase in Buffalo Red River Watershed District's general operating levy cap from \$250,000 to an amount not to exceed \$500,000.

#### 2017-05 Middle Fork Crow River Watershed District General Operating Levy Adjustment

MAWD supports the efforts of Middle Fork Crow River Watershed District to draft and advance special legislation affecting a change in its general fund levy cap.

#### 2017-06 Obtain Stable Funding for the Flood Damage Reduction Program

MAWD supports stable funding (as opposed to the current even year bonding process) for the DNR's Flood Damage Reduction Program. A suggested sustainable level of funding is \$25 million per year for the next 10 years.

# **URBAN STORMWATER**

#### 2017-04 Limited Liability for Certified Commercial Salt Applicators

MAWD supports passage and enactment of state law that provides a limited liability exemption to commercial salt applicators and property owners using salt applicators who are certified through the established salt applicator certification program who follow best management practices.

#### 2017-07 Creation of a Stormwater Reuse Task Force

MAWD supports legislation requiring creation of a Stormwater Reuse Task Force with membership from Watershed Districts, Cities, Counties, State Agencies and other Stormwater Reuse implementers; and that the Stormwater Reuse Task Force should be charged with developing recommendations that further clarify and/or replace the information in the Water Reuse Report that relates to stormwater reuse best management practices.

PUBLIC DRAINAGE LAW

#### 2019-02: Add a Classification for Public Drainage Systems that are Artificial Watercourses

MAWD supports removal of the default Class 2 categorization for public drainage systems that are artificial watercourses and supports a default Class 7 categorization for public drainage systems that are artificial watercourses.

# 2019-04: Clarify County Financing Obligations and/or Authorize Watershed District General Obligation Bonding for Public Drainage Projects

MAWD supports legislation to achieve one or both of the following:

- a) To clarify that an affected county must finance a watershed district drainage project on project establishment and request of the watershed district; and
- b) To authorize watershed districts to finance drainage project establishment and construction by issuance of bonds payable from assessments and backed by the full faith and credit of the watershed district; and further provide for adequate tax levy authority to assure the watershed district's credit capacity.

#### 2018-08 Reinforce Existing Rights to Maintain/Repair 103E Drainage Systems

MAWD supports legislation modeled after House File 2687 and Senate File 2419 of the ninetieth legislature (2017-2018) reinforcing that the DNR cannot restrict existing rights to maintain and repair 103E public drainage systems.

# LAKES AND WETLANDS

#### 2020-01 Appealing Public Water Designations

MAWD supports legislation that would provide landowners with a more formal process to appeal decisions made by the DNR regarding the designation of public waters including the right to fair representation in a process such as a contested case proceeding which would allow landowners an option to give oral arguments or provide expert witnesses for their case.

#### 2020-02 Limiting Negative Impacts from Wake Boats

MAWD supports:

- a) limiting wake boating to areas of lakes sufficiently distanced from shorelines to allow boat generated waves to adequately dissipate and lessen energy before coming into impact with lake shorelines;
- b) banning wake boats wakes in shallow lake areas where waves created by wake boats detrimentally impact sediment, aquatic vegetation, and aquatic habitat; and
- c) requiring new and existing wake boats to be able to completely drain and decontaminate their ballast tanks.

#### 2020-04 Temporary Water Storage on DNR Wetlands during Major Flood Events

MAWD supports the temporary storage of water on existing DNR-controlled wetlands in the times of major flood events.

#### 2019-07 Chinese Mystery Snail Designation Change and Research Needs

MAWD supports Chinese Mystery Snail prevention and control research and to change the Chinese Mystery Snail designated status in Minnesota as a regulated species to a prohibited species.

#### 2017-02 Temporary Lake Quarantine Authorization to Control the Spread of AIS

MAWD supports legislation granting to watershed districts, independently or under DNR oversight, the authority, after public hearing and technical findings, to impose a public access quarantine, for a defined period of time in conjunction with determining and instituting an AIS management response to an infestation.

# WATERSHED MANAGEMENT AND OPERATIONS

#### 2021-03: Support Increased Flexibility in Open Meeting Law

- MAWD supports changes to the Open Meeting Law to provide greater flexibility in the use of interactive technology by allowing members to participate remotely in a nonpublic location that is not noticed, up to three times in a calendar year per manager.
- MAWD supports allowing public participation from a remote location by interactive technology, or alternatively from the regular meeting location where interactive technology will be made available for each meeting, unless otherwise noticed under Minnesota Statutes Section 13D.021.
- MAWD supports changes to the Open Meeting Law requiring watershed districts to prepare and publish procedures for conducting public meetings using interactive technology.

#### 2021-06: Support 60-day Review Required for State Agencies on Policy Changes

MAWD supports requiring State Agencies to provide a meaningful, not less than 60-day review and comment period from affected local units of government on new or amended water management policies, programs, or initiatives with a response to those comments required prior to adoption.

#### 2021-07: Support Metro WBIF for Approves 103B Plans Only

MAWD supports BWSR distribution of metro WBIF among the 23 WMOs with state-approved comprehensive, multi-year 103B watershed management plans. Those plans implement multijurisdictional priorities at a watershed scale and facilitate funding projects of any eligible local government unit (including soil and water conservation districts, counties, cities, and townships).

#### 2020-03 Soil Health Goal for Metropolitan Watershed Management Plans

MAWD supports amending Minnesota Rule 8410.0080 to include a goal for soil health in watershed management plans and ten-year plan amendments.

#### 2019-01 Streamline the DNR permitting process

MAWD supports legislation, rules, and/or agency policies to streamline the DNR permitting process by increasing responsiveness, decreasing the amount of time it takes to approve permits, providing a detailed fee schedule prior to application, and conducting water level management practices that result in the DNR reacting more quickly to serious, changing climate conditions.

# 2019-03 Support for Managing Water Flows in the Minnesota River Basin Through Increased Water Storage and Other Strategies and Practices

MAWD supports efforts to manage the flow of water in the Minnesota River Basin and the Minnesota River Congress in its efforts to increase water storage on the landscape; and

MAWD supports the Minnesota River Congress in its efforts to secure state and federal programs targeted specifically to increase surface water storage in the Minnesota River Watershed.

#### 2019-05 Watershed District Membership on Wetland Technical Evaluation Panels

MAWD supports legislation to allow technical representatives of watershed districts to be official members of wetland technical evaluation panels (TEPs).

#### 2018-03 Require Timely Appointments to the BWSR Board

MAWD supports legislation that requires the Governor to make BWSR board appointments within 90 days of a vacancy or board member term expiration.

#### 2018-04 Require Watershed District Permits for the DNR

MAWD supports an amendment to the MN Statute § 103D.315, Subd. 5, to include the MN Department of Natural Resources as a state agency required to get permits from watershed districts when applicable.

#### 2018-06 Ensure Timely Updates to Wildlife Management Area (WMA) Plans

MAWD supports that WMA operation and maintenance plans and/or management plans are either drafted or brought current in a timely fashion, with input from local governmental entities, to ensure their consideration in future One Watershed, One Plan efforts.

#### 2018-09 Clean Water Council Appointments

MAWD may ask the representative of the Clean Water Council to resign when they lose their direct association to a watershed district; and that MAWD will recommend to the Governor's office that managers and/or administrators in good standing with MAWD be appointed to the Clean Water Council.

# **Resolutions to Sunset**

Effective December 31, 2022

In accordance with MAWD's Sunset Policy, the following resolutions will be archived at the end of 2022 and will no longer be considered for future legislative and administrative platforms. The Sunset Policy says that resolutions older than five years old shall be removed from the books. If your watershed feels any of these issues should continue to be actively pursued with MAWD resources, then your watershed board needs to submit the resolution and the issue will need to be voted on and renewed by the membership at the annual meeting in December 2022. Please see previous sections for language associated with the following resolutions set to expire.



(KNSI) — Stearns County is among the 23 Minnesota counties getting funding as part of a federal disaster declaration.

The money from the Federal Emergency Management Agency is considered public assistance, which can fund the repair, restoration, reconstruction, or replacement of eligible public or certain nonprofit facilities or infrastructure damaged or destroyed by a disaster.

A press release from Governor Tim Walz's office explains that on the morning of Sunday, May 8th, thunderstorms generated winds over 60 miles per hour that swept through Stearns and Morrison counties, downing trees and power lines. The following day, May 9th, tornados touched down. They ranged from an EF0 twister near Hastings to a cluster of five tornados – one with winds exceeding 110 miles per hour – in central Minnesota, causing extensive damage. On May 11th, five tornadoes touched down in southwestern Minnesota to the northeast through the Twin Cities. On May 12th and 13th, the southern two-thirds of the state experienced violent and dangerous storms, and at least six tornadoes were confirmed in west-central Minnesota.





The damage is estimated to be nearly \$11 million.

"This spring brought unprecedented storms and historic flooding to our state. But time after time I've seen people put their neighbors' needs ahead of their own while facing devastating consequences to their homes, farms, and businesses," said Governor Walz. "While the state continues to help in every way we can, we need the federal government's help. I'm grateful that more assistance is on its way, and I'm committed to continuing the work to rebuild."

The Governor has also requested assistance for two other weather-related events in recent weeks, including a disaster declaration request for federal aid for ongoing flooding in Northwestern Minnesota and an extension for the timeline to request support for a Memorial Day tornado outbreak that caused significant damage in more than 20 counties to complete damage assessments.

This federal disaster declaration unlocks public assistance for Aitkin, Big Stone, Cass, Chippewa, Cottonwood, Douglas, Grant, Kandiyohi, Lac Qui Parle, Lincoln, Morrison, Nobles, Pope, Redwood, Renville, Stearns, Stevens, Swift, Todd, Traverse, Wadena, Wilkin, and Yellow Medicine Counties to assist with emergency work and the repair or replacement of disaster-damaged facilities.
